Notice Order of November 19, 2012, on March 11, 2013, at 10:00 a.m., or as soon
thereafter as counsel may be heard, at the U.S. Courthouse, 312 North Spring
Street, Los Angeles, CA 90012, before the Honorable Christina A. Snyder, United
States District Judge, Plaintiffs, through their Counsel, will move pursuant to Fed.
R. Civ. P. 23(e) for an Order: (1) awarding attorneys’ fees in the amount of

1 \$606,250 and awarding Lead Plaintiffs \$4,500 (\$1,500 each); (2) reimbursing
2 \$85,594.43 in expenses that were incurred in prosecuting this action. Plaintiffs’
3 motion is based on the Memorandum of Law in Support; the Declaration of
4 Laurence M. Rosen in Support of Plaintiffs’ Motion for Final Approval of Class
5 Action Settlement and Plan of Allocation, and Award of Attorneys’ Fees and
6 Reimbursement of Expenses; the Stipulation and Agreement of Settlement dated
7 October 3, 2012; and all other pleadings and matters of record and such additional
8 evidence or argument as may be presented at the hearing. A [Proposed] Order
9 approving the requested award of attorneys’ fees and expenses is filed herewith.
