The Supreme Court of the State of New York, County of New York, has preliminarily approved a proposed class action Settlement of all claims in the action captioned *Todd France, et al. v. Jiayin Group, Inc., et al.*, 654398/2020 (Sup. Ct. N.Y.). The Settlement resolves all of the claims that Defendants violated the Securities Act of 1933 by making allegedly false and misleading statements to the investing public, which allegedly caused the Settlement Class to purchase Jiayin Group, Inc. American Depository Shares (“ADSs”) at artificially inflated prices. Defendants expressly deny all Plaintiff’s allegations of wrongdoing or liability whatsoever and deny that the Settlement Class Members’ losses are compensable under the securities laws.

You received this Postcard Notice because you or someone in your family may have purchased and/or acquired Jiayin ADSs between May 10, 2019 and September 2, 2020, inclusive, pursuant and/or traceable to Jiayin’s initial public offering issued on May 10, 2019, and you may be a Settlement Class Member. The Settlement provides that, in exchange for the dismissal and release of claims against Defendants, a fund consisting of \$2,000,000, less attorneys’ fees and expenses and compensatory award to Plaintiff Todd France, will be divided among Settlement Class Members who timely submit a valid Proof of Claim and Release Form (“Claim Form”). The Claim Form can be found on the website, [www.strategicclaims.net/Jiayin/](http://www.strategicclaims.net/Jiayin/), or will be mailed to you upon request to the Claims Administrator at the address below.

Claim Forms must be electronically submitted by 11:59 p.m. on December 9, 2022 at [www.strategicclaims.net/Jiayin/](http://www.strategicclaims.net/Jiayin/). Mailed Claim Forms must be postmarked by December 9, 2022 to the Claims Administrator. If you do not want to be legally bound by the Settlement, you must exclude yourself by November 11, 2022 or you will not be able to sue the Defendants about the legal claims in this case. If you exclude yourself, you cannot get money from this Settlement. If you stay in the Settlement, you may object to it by November 11, 2022. The detailed Notice explains how to submit a Claim Form, exclude yourself, or object.

The Court will hold a final settlement hearing in this case on December 2, 2022 at 11:30 a.m. at the Supreme Court of the State of New York, County of New York, 60 Centre Street, Room 238, New York, NY 10007, to consider whether to approve the Settlement, the Plan of Allocation, and a request by Class Counsel for up to 33% of the Settlement Fund for attorneys’ fees, plus up to \$150,000 for actual expenses and up to \$5,000 in a compensatory award for Plaintiff Todd France. You may attend the hearing and ask to be heard by the Court, but you do not have to.
