AFFIDAVIT OF DINNAH HOLLIFIELD

- I, Dinnah Hollifield, being duly sworn do depose and say as follows:
 - I was an employee of the City of Charlotte working in the Charlotte Mecklenburg Police
 Department from 1974 until 1996, when I resigned. After a promotion I was transferred
 to the Human Resources Department of the Charlotte Mecklenburg Police Department.
 In that capacity, I was responsible for the entry of payroll information hours worked,
 overtime worked, vacation and sick leave to be used by the City for pay purposes.
 - 2. Later, during the period 1986 through 1996, I was a Benefits Coordinator (Administrative Officer) in the Human Resources Department of the Charlotte Mecklenburg Police Department.
 - 3. As a Benefits Coordinator during the period 1986 through 1996, I presented and described the operation of the Voluntary Police Pledge Fund and other employment benefit materials employee enrollment materials, retirement forms and insurance materials (health and life) to each new recruit class at the Police Academy on the first day of their "in processing." It is my recollection that I presented to two to three recruiting classes a year. When I resigned in 1996, I was replaced by Mary Broadrick who I trained.
 - 4. I made the benefits presentation using a "New Hire Packet" which was created by and in the Human Resources Department of the Charlotte Mecklenburg Police Department using materials paid for by City of Charlotte. For the Pledge Fund, the recruits were provided a heavy paper stock card which was required to be filled out indicating their participation in the Volunteer Police Pledge Fund, authorizing a \$5 weekly deduction when required, and providing beneficiary information. During my time as Benefits Coordinator this pledge fund was only made available to sworn personnel.
- 5. The vast majority of each recruit class I presented to signed up for the Pledge Fund.

- 6. A Pledge Fund participant agreed to support a retiring Pledge Fund participant or the beneficiary of a deceased Pledge Fund participant with a \$10 contribution by having \$5 deducted from his or her pay for two consecutive weeks when needed, such that the retiring participant would receive \$10 from each then Pledge Fund participant. In exchange for his or her participation, the Pledge Fund participant would receive \$10 from each then Pledge Fund participant upon his or her retirement or his or her beneficiary would receive the amount upon death.
- 7. As Benefits Coordinator, I advised the City's Payroll section by typed memo who had joined the Pledge Fund and who had withdrawn from the Pledge Fund. I also advised who was retiring or who had deceased.
- 8. During the time I was a Benefits Coordinator, money was only deducted from the pay of Pledge Fund participants when I advised the Finance Department that such was required to meet an existing obligation to pay a retired Pledge Fund participant or the beneficiary of a deceased Pledge Fund participant.

- 11. As of April 1996, when I resigned, money was only withdrawn from participants' pay when I advised that deductions should be taken to meet a Pledge Fund obligation a retirement, or death. When money was withdrawn from a participant's pay, it was provided to the appropriate Pledge Fund participant or the appropriate beneficiary by the above-described process. There was never an accumulation of money in the Pledge Fund bank account from the

City was immediately disbursed to the appropriate Pledge Fund participant or beneficiary.

- 12. While the Charlotte Mecklenburg Police Department had a dedicated Human Resources Department, it did not have a finance department. The Police Department was paid by the Finance Department of the City of Charlotte. AFFIDAVIT OF MARY BROADWICK

- I, Mary Broadrick, being duly sworn do depose and say as follows:
 - I was an employee of the City of Charlotte working in the Charlotte Mecklenburg Police
 Department from March 1, 1975, until December 1, 2003, when I retired. I was first
 assigned to the Human Resources Department of the Charlotte Mecklenburg Police
 Department in 1986. In that capacity, I was responsible for the entry of payroll
 information hours worked, overtime worked, vacation and sick leave to be used by
 the City for pay purposes.
 - 2. Later, during the period March 1996 through December 1, 2003, I was a Benefits Coordinator (initially Administrative Officer 1; later Administrative Officer 2) in the Human Resources Department of the Charlotte Mecklenburg Police Department.
 - 3. As a Benefits Coordinator during the period March 1, 1996, through December 1, 2003, I presented and described the operation of the Voluntary Police Pledge Fund and other employment benefit materials employee enrollment materials, retirement forms and insurance materials (health and life) to each new recruit class at the Police Academy on the first day of their "in processing." It is my recollection that I presented to two or three recruiting classes a year.
 - 4. I made the benefits presentation using a "New Hire Packet" which was created by and in the Human Resources Department of the Charlotte Mecklenburg Police Department using materials printed in the Charlotte's Print Department and paid for by City of Charlotte. For the Pledge Fund, the recruits were provided a heavy paper stock card which was required to be filled out indicating their participation in the Volunteer Police Pledge Fund, authorizing a \$5 weekly deduction when required, and providing beneficiary information.
 - 5. The United Way and other fundraising information for charitable organizations were not presented to new recruits as part of the "New Hire Packet." Only materials related to benefits were presented and the Pledge card and other information related to the employee's benefits and beneficiary information were kept in the employee's

personnel file in the Human Resources Department. The vast majority of each recruit class I presented to signed up for the Pledge Fund.

- 6. The Pledge Fund presentation was straightforward. A Pledge Fund participant agreed to support a retiring Pledge Fund participant or the beneficiary of a deceased Pledge Fund participant with a \$10 contribution by having \$5 deducted from his or her pay for two consecutive weeks when needed, such that the retiring participant would receive \$10 from each then Pledge Fund participant. In exchange for his or her participation, the Pledge Fund participant would receive \$10 from each then Pledge Fund participant upon his or her retirement or his or her beneficiary would receive the amount upon death.
- 7. As Benefits Coordinator, I advised the City's Payroll section by typed memo who had joined the Pledge Fund and who had withdrawn from the Pledge Fund. I also advised who was retiring or who had deceased.
- 8. During the time I was a Benefits Coordinator, money was only deducted from the pay of Pledge Fund participants when I advised the Finance Department that such was required to meet an existing obligation to pay a retired Pledge Fund participant or the beneficiary of a deceased Pledge Fund participant.
- 9. When advised, the City would cut a check to the Pledge Fund on a City of Charlotte account and send the check to me. I maintained deposit slips for the Pledge Fund account and would prepare a deposit slip for the City of Charlotte check and have the check deposited into the Pledge Fund bank account. A police officer came to the Human Resources Department every morning to pick up items for distribution to the City offices and as part of his rounds, we had him deposit the City of Charlotte check in the Pledge Fund bank account.
- 10. Once the Pledge Fund check written by the City had been deposited in the Pledge Fund bank account, I would type a check from the Pledge Fund checkbook which I maintained and contact the Pledge Fund participant to pick up his or her check. In the case where the Pledge Fund participant had passed, I would arrange for the check to be delivered to the beneficiary.

- 11. As of December 2003, when I retired, money was only withdrawn from participants' pay when I advised that deductions should be taken to meet a Pledge Fund obligation a retirement, or death. When money was withdrawn from a participant's pay, it was provided to the appropriate Pledge Fund participant or the appropriate beneficiary by the above-described process. There was never an accumulation of money in the Pledge Fund bank account. The money that went into the Pledge Fund bank account from the City was immediately disbursed to the appropriate Pledge Fund participant or beneficiary.
- 12. While the Charlotte Mecklenburg Police Department had a dedicated Human Resources Department, it did not have a finance department. The Police Department was paid by the Finance Department of the City of Charlotte. The information the Fund participants filled out to authorize the payroll deduction was maintained by the Human Resources Department and communicated to the City of Charlotte Finance Office when payroll deductions needed to be taken and payment to a Pledge Fund participant was needed.
- 13. Without question, the Pledge Fund program was a benefit and as a Human Resources professional, I believe the Charlotte Mecklenburg Police Department and the City of Charlotte obtained recruiting and retention benefits from the existence of the Pledge Fund.

KEITH WAY AFFIDAVIT

- I, Keith Way, after being duly sworn do depose and say as follows:
- 1. I was a member of the Charlotte Mecklenburg Police Department for 24.5 years. I was hired on February 24, 1988 and was a member of the recruit class no. 90. I retired on March 01, 2017.
- 2. During the recruit class presentation about benefits, I was informed about the opportunity to participate in the Volunteer Police Pledge Fund. The class was told that if we agreed to have \$5 deducted weekly from our pay, which Funds would be used to provide \$10 to each Pledge Fund participant who retired, we would receive at our retirement an amount equal to \$10 x the then number of Pledge Fund participants. We were told this was approved by the City of Charlotte.
- 3. While joining the Pledge Fund was said to be "voluntary," there was social and command pressure to join. It was made clear that joining the Pledge Fund would benefit the senior members of the Charlotte Mecklenburg Police Department for whom we would be working and who would have some influence over our careers, would resulting in participants being part of the team, and would benefit me and my classmates when we retired in an amount equal to \$10 x the then number of Pledge Fund participants.
- 4. My recollection is that a majority of recruits in Pledge class 90 joined the Pledge Fund. Jeffry Butler and Terry Roper, who have also retired, but not received their Pledge Fund payment, were also in my class. I understand that the other members in recruit class no. 90 who joined the Pledge Fund have already received their payouts.
- 5. The Pledge Fund was administered by the Human Resources Department of the Charlotte Mecklenburg Police Department and the Finance Department or Payroll Department. A list of Pledge Fund participants was maintained by the Human Resources Department of the Charlotte Mecklenburg Police Department and the weekly Pledge Fund deductions were taken out by the Finance Department or the Payroll Department of the City of Charlotte.
- 6. When I retired, I was told by the head of the Charlotte Mecklenburg Police Department, Human Resources Department Justin Lee that there was not sufficient funds to pay Pledge Fund participants immediately upon retirement, in fact payments had been substantially delayed because of the number of retirees and the salary deduction process. To determine where one was on the list, one would have to check with the head of the

Charlotte Mecklenburg Police Department Human Resources Department Human Resources department.

- 7. The head of the Human Resources Department was occupied by a sworn officer early in my career, but later by a civilian employee of the City of Charlotte who was assigned to the Charlotte Mecklenburg Police Department Human Resources department. The last years of my employment the position was occupied by Justin Lee.
- 8. My understanding is that Mr. Lee is still an employee of the City of Charlotte, but no longer works in the Charlotte Mecklenburg Police Department. As part of the out processing, I met with Mr. Lee, who upon reviewing the Pledge Fund participant list he maintained in his office, confirmed that I was a Pledge Fund participant.
- 9. Mr. Lee explained the Pledge Fund payout process as part of the same meeting where he explained the other retirement benefit to which I was entitled, and Mr. Lee definitely described the Pledge Fund and referred to the Pledge Fund as a benefit of being a member of the Charlotte Mecklenburg Police Department. Mr. Lee explained that my Pledge Fund payment would be delayed but did not provide specific guidance when I might expect it.
- 10. Some time passed after which I again contacted Mr. Lee who, after checking his list, informed me that I was the next person on the list to receive a Pledge Fund benefit and should receive my check in several weeks. Unfortunately, that never happened, and I have yet to receive the payout I was promised at the Police Academy benefits briefing presented to recruit class no. 90.

AFFIDAVIT OF KATRINA GRAUE

I, Katrina Graue, after being duly sworn does depose and say:

- I was an employee of the City of Charlotte and a member of the Charlotte-Mecklenburg Police Department for 29 years. I was hired on July 25, 1990, and a member of the Police Academy Recruit Class no. 102. I retired on July 1, 2019. During my career, I rose from recruit to Deputy Chief and occupied a number of different job positions as a Deputy Chief.
- 2. During the recruit class presentation about benefits, I was informed by Charlotte Police Department Human Resources representative about the opportunity to participate in the Voluntary Police Pledge Fund. The Pledge Fund was presented as a benefit of employment of the Charlotte Police Department along with other benefits like life insurance and 401K retirement plans.
- 3. The Pledge Fund presentation was straightforward. A Pledge Fund participant agreed to support a retiring Pledge Fund participant or the beneficiary of a deceased Pledge Fund participant with a \$10 contribution by having \$5 deducted from his or her pay for two consecutive weeks when needed, such that the retiring participant would receive \$10 from each then Pledge Fund participant. In exchange for his or her participant upon his or her retirement or his or her beneficiary would receive the amount upon death.
- 4. While joining the Pledge Fund was said to be "voluntary," there was certainly strong social and command pressure to join. It was clear that joining the Pledge Fund was expected and it did not feel like it was optional. I understood that it would benefit retirees and me, one day, when I retired. It would also result in me being part of the "team," and would benefit me and my classmates when we retired in an amount equal to \$10 times the then number of Pledge Fund participants.
- 5. Based on the explanations provided, I did not believe the Pledge Fund was "voluntary," but rather was presented in the first few days of the Police Academy in a way that created substantial pressure to join. I know from conversation that my classmates who also joined did not believe it was voluntary. My recollection is that a majority of the recruits in Recruit Class 102 joined the Pledge Fund and also felt social and command pressure to join.
- 6. The Pledge Fund was never an organization and certainly never administered anything; rather the Pledge Fund was administered by the Human Resources Department of the Charlotte Mecklenburg Police Department which maintained the list of Pledge Fund participants.
- 7. It is my understanding that when a Pledge Fund participant retired or passed (a) the Human Resources Department of the Charlotte Mecklenburg Police Department would advise the Finance Department of the City of Charlotte of the retirement or death, (b) the Finance Department would deduct \$5 from the weekly pay of each Pledge Fund participant as required

to meet the obligation, (c) the Finance Department would then cause a check to be written in the amount of \$10 x the number of Pledge Fund participants, (d) the Finance Department would transfer that check to the Human Resources Department of the Charlotte-Mecklenburg Police Department, and (e) the Human Resources Department would cause the check would be delivered to the retired Pledge Fund participant or would cause the check to be delivered to a member of the Charlotte Mecklenburg Police Department for delivery to the retired Pledge Fund participant. More recently, the Finance Department would write the check to Pledge Fund bank account advising the identity of the intended beneficiary.

- 8. At some point, the checks from the City of Charlotte were made out to the Voluntary Police Pledge Fund and would be given to a member of Police Department indicating the Pledge Fund participant to whom the check amount should be directed.
- 9. I was part of leadership group on the Charlotte Mecklenburg Police Department that was aware an Audit of the Pledge Fund. We were told that the audit would be made available, but it was not. I asked for a copy of the report and was told it had been given to another police assistant Chief but was told by her it was not given to her. I believe that the audit was undertaken by Marie Marsicano in City Audit.
