**STIPULATION AND [PROPOSED] ORDER
 SCHEDULING FINAL APPROVAL HEARING**

WHEREAS, on June 26, 2024 the parties to the above-captioned action entered into a Stipulation of Settlement;

WHEREAS, on August 5, 2024, the Court granted an order preliminarily approving the class action settlement, preliminarily certifying the class for settlement purposes, approving the form and manner of class notice, and preliminarily approving the plan of allocation (the “Preliminary Approval Order”); and

WHEREAS, on August 5, 2024, the Court requested that the parties confer regarding a date and time to schedule a hearing to determine, among other things, whether to grant final approval of the proposed settlement (the “Final Approval Hearing”);

IT IS HEREBY STIPULATED AND AGREED, by the parties hereto, through their undersigned counsel, and subject to the approval of the Court, that the following schedule shall apply to the Final Approval Hearing and associated deadlines:

1. **Final Approval Hearing.** A hearing pursuant to paragraph 6 of the Preliminary Approval Order is scheduled in person for December 4, 2024 at 1:00 p.m.

2. **Petition for Attorney's Fees and Litigation Costs and Case Contribution Awards.** Any petition pursuant to paragraph 8 of the Preliminary Approval Order shall be filed no later than thirty-five (35) days before the Final Approval Hearing, or October 30, 2024.

3. **Briefs in Support of Final Approval of the Settlement.** Briefs and other documents submitted pursuant to paragraph 9 of the Preliminary Approval Order shall be filed no later than thirty-five (35) days before the Final Approval Hearing, or October 30, 2024.

4. **Objections to Settlement.** Any members of the Class wishing to make any objections pursuant to paragraph 10 of the Preliminary Approval Order shall file their objections with the Court, mail or email copies to Class Counsel and to counsel for the Defendants, and mail a notice of appearance of any attorney representing them, no later than twenty-one (21) days before the Final Approval Hearing, or November 13, 2024.

5. **Supporting Briefs.** Any additional briefs the Parties may wish to file pursuant to paragraph 11 of the Preliminary Approval Order shall be filed no later than seven (7) days before the Final Approval Hearing, or November 27, 2024.

6. **Appearance at Final Approval Hearing.** Any objectors or their attorneys intending to appear at the Final Approval Hearing pursuant to paragraph 12 of the Preliminary Approval Order shall serve a notice of intention to appear and file it with the Court by no later than fourteen (14) days before the Final Approval Hearing, or November 20, 2024.
