**NOTICE OF LEAD PLAINTIFF'S MOTION FOR AN AWARD OF ATTORNEYS'  
FEES, REIMBURSEMENT OF EXPENSES, AND COMPENSATORY  
AWARD TO LEAD PLAINTIFF**

**PLEASE TAKE NOTICE** that Lead Plaintiff Boris Lvov (“Plaintiff”), individually and on behalf of all Settlement Class Members, through their undersigned attorneys, respectfully move this Court, the Honorable Andrew L. Carter Jr., United States District Judge of the United States District Court for the Southern District of New York, 40 Foley Square, Courtroom 444, New York, NY 10007, on May 19, 2026, at 2:00 PM, for entry of an Order: (i) awarding attorneys’ fees in the amount of one third of the Settlement Fund, or \$6,656,666.67, plus interest at the same rate as the Settlement Fund; (ii) paying Litigation Expenses in the amount of \$130,000 incurred in prosecuting the action, plus accrued interest; and (iii) awarding Lead Plaintiff Boris Lvov \$10,000 for their work directly related to their representation of the Settlement Class, as authorized by the Private Securities Litigation Reform Act of 1995, plus accrued interest.
